Members agreed to:

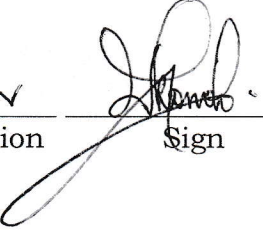
- Acquaint themselves with the objects of the organization.
